The Village of Lombard has not compensated me as a Lombard homeowner, Victim of Heinous Hate Crimes.

Honorable Bruce Rauner, Office of the Governor of Illinois, Springfield and Chicago:

My name is Gardenia de la Caridad Hung Fong (Wittler), DOB 27 December 1958. I am the surviving daughter, Executor Trustee of the Estate of the late Mr. Roberto Hung Juris Doctor and his surviving widow Mrs. Gardenia Fong Ramos. I have been a Victim of Violence Against Women, physical abuse, kidnappings, torture, and denial of human rights and civil rights as a Lombard resident homeowner at the same address, after Mr. Roberto Hung and myself made a full payment for the same real estate property on September 2, 1996, at the First State Bank of Maple Park in Kane County, Illinois USA.

Twenty-four (24) years have passed since my late Father, Mr. Roberto Hung Juris Doctor purchased the Lombard Brick Bungalow from Debra Seckreki and her father Adam Seckreki on September 2, 1993. Even now, during the second week of March 2017, I have not yet received any Cash Payment Settlement, Restitution, Restoration, Reimbursement, Recovery and/or Compensation for the Lombard Criminal Roofing Water Damages and Losses at 502 South Westmore-Meyers Road and the Company Communications, Languages & Culture Inc. or for my Personal Losses and Damages for the Estate of Gardenia C. Hung (Wittler) or for Nathan Scott Wittler Patriquin.

To date, I still do not have any money for the sale of the Lombard real estate property, nor have I received any restitution for Lombard Criminal Roofing Water Damages and Losses to my private property, belongings, fashion clothing, business electronic equipment and resources for the Company Communications, Languages & Culture Inc., gourmet kitchen equipment, the Pampered Chef utensils,

baking ware, cooking ware, etc. No one ever talks to me, contacts me, meets with me, notifies me, informs me or invite me as part of the civil procedure in the Village of Lombard, York Township, Du Page County, Illinois USA.

I have been displaced since the Village of Lombard demolished my Lombard home at 502 South Westmore-Meyers Road on November 5, 2008 arranged by the Lombard Police and Fire Department in District 5, York Township, Du Page County, Illinois.

The Village of Lombard has not provided the required housing to replace the Lombard Criminal Roofing Damages and Losses and the Demolition by the Lombard Police and Fire Department. York Township Senior Center did not provide Senior Housing facilities or accommodations for me, a Lombard resident homeowner, Victim of Heinous Hate Crimes at 502 South Westmore-Meyers Road and Washington Boulevard in District 5.

My name is Gardenia C. Hung (Wittler). I am writing to the Office of the Governor of Illinois because I have not been compensated for the Lombard Criminal Damages and Losses or the Demolition of my Lombard Brick Bungalow at 502 South Westmore-Meyers Road and Washington Boulevard, to the Estate of Gardenia de la Caridad Hung Fong (Wittler) and the business assets for the Company Communications, Languages & Culture Inc.

I am still suffering from financial hardship and displacement since November 5, 2008 when the Village of Lombard Police and Fire Department demolished my Lombard Brick Bungalow. For the last, nine (9) years, I have not been given any housing accommodations by the Village of Lombard or any senior housing amenities by York Township Senior Center Services either. I am already living my senior years as an Illinois resident and U.S. citizen having worked and paid for Illinois real estate property in full. However, I have not been compensated as an Illinois Victim of Heinous Hate Crimes, Violence Against Women, Domestic Violence, Crimes Against Humanity by the Village of Lombard, York Township, DuPage County, Illinois in the USA.
